# 1. Purpose of Report

1.1 To provide the Board with an update in relation to the progress regarding the formulation of the Town Investment Plan (TIP).

# 3. Background Information

- 3.1 The Towns Fund process is in two phases with a decision gateway at the end of each. The first phase requires the submission of a TIP. The TIP will then be assessed by the Ministry for Housing Communities and Local Government (MHCLG), with Heads of Terms offered to towns whose TIP is judged to be of sufficient quality.
- 3.2 Following discussion in relation to the merits to amending the submission date, following the announcement of Cohort 2a, at its meeting on 23<sup>rd</sup> October 2020, the Board resolved to move its submission of the TIP to cohort 2a, the deadline for which is the 11<sup>th</sup> December 2020.

## 4. Current Progress

### Project Plan Revision

4.1 Following the decision to move to cohort 2a, the Project Plan has been further revised to reprofile the appropriate ensure the TIP is submitted on time. In order to meet the governance timetable, i.e., sign off by Board and sign off by Nuneaton and Bedworth Borough Council Cabinet (NBBC), completion of all documentation must be achieved by 27<sup>th</sup> November 2020;

# **Narrative**

- 4.2 A second check & challenge has been undertaken, with the feedback being received 9<sup>th</sup> November 2020. The key points to continue to develop are:
  - Expand upon the engagement undertaken, both as part of the TIP development and other engagement undertaken, for example, for the Future High Streets Fund;
  - The flow of the document could be improved with a suggestion that the sections are re-positioned;
  - The golden thread requires further strengthening;
  - Expand upon the challenges and associated impacts for the town and describe them spatially;
  - The Covid narrative is good;
  - Good information on challenges and evidence of need;
- 4.3 The check and challenge also commented upon the outstanding information. This includes for example, the finalisation of the theory of change, both at a programme

- level and at project level and the delivery plan. It is noted that these cannot be completed until the final project list has been agreed by Board.
- 4.4 The project team continue to refine the narrative. It has been agreed with the Town Deal Delivery Partner that section specific feedback will be undertaken moving forward, given that the remaining timeframe. A draft of the TIP narrative will be shared with the Board once all comments have been addressed.

#### Project Prioritisation

4.5 The Project Prioritisation Panel completed and submitted their assessments on Monday 9<sup>th</sup> November 2020. Moderation was undertaken on Monday 9<sup>th</sup> and Tuesday 10<sup>th</sup> November 2020. The Scores relating to the Green Book assessment were completed by the consultants on Wednesday 11<sup>th</sup> November 2020. All information was fed into the Project Prioritisation Tool to identify the overall scores for each project. The confidential paper at Agenda Item 8, deals with this matter in detail.

#### 5 Conclusion

5.1 Progress continues and support and feedback continues to be sought from both the Town Deal Delivery Partner and the CLGU Lead. This is to ensure, as far as is possible, that we are able to submit a high quality TIP.
