The Chief Executive Officer submitted a report detailing the terms of reference for the sub-committee. The draft terms of reference had been circulated to key senior officers and group leaders prior to being adopted by the Chief Executive Officer through a Delegated Authority by Officer decision (DO/16/2025 (TS)). The terms of reference were included in the agenda for review and noting.

LGR04PeopleToo Report

The Chief Executive of PeopleToo - Maggie Kenney presented the report on the Future of Social Care that was commissioned by the District and Borough Councils to provide analysis around the future of social care in a one or two unitary model for Warwickshire.

The following summarised points were raised:

- Concern over the demand pressures of adult and children services and budget gap that would need to be covered.
- Concern that a unitary will take local knowledge away when providing services to the residents.
- A two unitary model could provide opportunity to refine social care services at a local level and enable better delivery of outcomes.
- Important to examine what services need to be commissioned in respect of social care.
- The amount of work required takes considerable time and resources to enable a stable transition period, concern that the current timeframe of three years is not going to be adequate to enable proper consideration of all the factors.
- Concern over redundancies and the costs associated with this when creating the unitary councils.

 A business case to look at local initiatives that are not statutory to examine what benefits this would have.
