RECORD OF THE DECISION

a) The issue

Legal Counsel / Barristers Framework Agreement

The option has come about via a group of local authorities across the West Midlands. Officers have been involved in discussions for the provision of a Legal Counsel/Barristers framework agreement, being led by Wolverhampton Council. 16 Contracting Authorities interested. The services therefore relate to providing Counsel advice, representing the Council in tribunal and courts and such like. Wolverhampton Council are taking the lead (ref procurement process) and will be the ultimate local authority meaning they take the risk, however there is an expectation that each participating authority has at least 1 representation their Council in the process. A Memorandum of Understanding between Wolverhampton and participating authorities will be in place to govern the collaboration of the procurement process and framework agreement. The Council hasn't had anything of this nature before other than the recently procured Legal Services Framework Agreement. The benefit primarily is that it should deliver savings to the Council in the long term rather than going direct to a chamber should the Council encounter similar levels of spending associated with Barristers and Counsel. Reference has been to the same/similar framework operating amongst the London Borough's and they are on their 3rd iteration of the same concept/framework. To sign up, the Council will be committed to spend £5,000 to Wolverhampton Council for the fees associated to the establishment of the Framework Agreement. This will need to be paid in full upon signing the MoU. The same fee applies to all participating local authorities.

b) The Decision

- B.1. To sign the MoU with Wolverhampton Council and be a participating Local Authority for the purposes of the forthcoming procurement process for the establishment of a Barrister/Counsel Framework Agreement.
- B.2. To participate in the procurement process and be a named Council in the collaborative exercise.
- B.3. To pay Wolverhampton Council £5,000 for establishing and creating the Framework Agreement for the Council to have access to use during the term of the Framework Agreement.

REASON FOR THE DECISION

Purchase orders raised since June 2022 until end of July 2025, indicate the Council has committed circa £475k. Circa £400k of that, related to planning inquiries. This is however not reflective of potential future demand which is unknown.

Based on previous level of spend, a suggested saving of 10% - 20% given economies of scale for up to 16 local authorities. A commitment of £5,000, based on value for money perspective evidences the decision for forming part of the consortium of participating local authorities. Based on previous spend of circa £475k, even with a 5% saving, shows a return on investment. That is however all subject to a similar level of future requirement.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED IN MAKING THE DECISION

No to join the consortium and do nothing – reason for rejection: if spend levels are consistent with last 3 years, it may cost more despite the £5,000 commitment to Wolverhampton. It also ensures value for money as the costs would be competitively priced on the open market and it'll help provide certainly for NBBC on costs going forward for these service requirements.

Procuring our own framework – this would take up officer time and if the Council acted alone, it wouldn't have the economies of scale compared to up to 16 collaborating local authorities.
