RECORD OF THE DECISION

a) The issue

Household Dry Recycling Collections have been delivered by Coventry City Council through a shared service agreement that was signed on the 15th October 2018 (Appendix A). The original agreement was an initial term of 7 years, with the option to extend for any period up to an additional 7 years, this option was exercised for an additional year in 2024 through to March 2026.

To ensure the consistent and uninterrupted statutory service delivery, an additional extension is required, at a proposed duration of 2 years – to 31st March 2028.

A variation to the agreement has been proposed and informally agreed by both parties. NBBC legal and procurement teams have confirmed their satisfaction with the variation, which carries no financial implications to NBBC or changes to the service delivered to residents. The changes ensure a best practise approach is taken, ensuing updates to outdated information, and ensures improvements to communication channels and processes between both parties, to aid consistent and acceptable service delivery during the extension period.

b) The Decision

- i) To extend the household recycling collections shared service agreement with Coventry City Council by an additional 2 years.

and

- ii) To approve the variation for formal submission and execution.

REASON FOR THE DECISION

A Contract extension was previously agreed to allow for a review of the service provision to be undertaken due to the upcoming changes to waste collection services through simpler recycling as set out in the Environment Act 2021.

A review was undertaken into the provision of space and infrastructure currently available at the Council Depot at Gresham Road, with awareness and consideration to the legislative requirement to provide mandatory food waste collections in 2026.

The Council will be required to provide weekly food waste collections to all households within the Borough – requiring additional collection vehicles to be housed at the Council's Gresham Road Depot. Work is ongoing to enable this within the existing infrastructure constraints at Gresham Road Depot. Initial reports from the surveyors indicate that there are insufficient space for further vehicles beyond those required for the new food waste service and those already housed at the Depot.

As part of the review the Council has also procured its own routing software, which will allow for review of all vehicles used to deliver waste and street cleansing services.

Attempts were made in late 2024 to market test the service to understand the operates this would bring, however there was no interest from possible service providers. As such, open pre-market engagement for household recycling collections will be required to consider alternative outsourcing options and aid decision making for the future of the household recycling collections when this extension ends.

The extension will allow additional time to explore the options for the service delivery and plan for the future of the recycling collections as well as allow the new food waste collection service to acclimatise.

Following discussion with Coventry City Council, an extension period of two years is proposed initially, at which point the lifetime of the vehicles used on the service will require renewal – requiring a longer shared service agreement renewal, or alternative delivery models for the service to be implemented.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED IN MAKING THE DECISION

In house provision

Rejected - Due to space constraints at the Council's Gresham Road Depot, further infrastructure and land provision scoping and exercises need to take place to consider this option fully and compare with other options.

To re-procure

Rejected - Soft market testing was unsuccessful, open pre-market engagement is required to aid decision making and inform officers of supplier availability.

WARD RELEVANCE

The recycling service provision is standardised across Nuneaton and Bedworth, the extension will not impact residents as there are no changes to how the service will be delivered.
