# 1.0 Local Plan Timetable

The Nuneaton and Bedworth Borough Local Plan will focus on providing a clear vision and strategy for growth, identifying land for development where appropriate, and include locally specific planning policies.

The [Town and Country Planning \(Local Planning\) \(England\) Regulations 2026](#) came into effect in March 2026. One requirement of this new legislation is that local authorities must publish a Local Plan Timetable defining key plan-making milestones. The timetable must be available before or alongside the publication of the Notice of Intention to Commence; updated at least once per month; and updated on the same day that the following stages are reached:

- Publication of Gateway 1 self-assessment summary
- Publication of Gateway 2 observations and advice
- Publication of Gateway 3 observations and advice
- Publication of the examiner’s recommendations and reasons following the examination

If a pause in the examination of the plan occurs, if the Council repeats Gateway 3 or if the plan is withdrawn or revoked, the Local Plan Timetable will also be updated on the same day.

If the Council decides to hold further, optional consultations, this Local Plan Timetable will be updated as soon as is reasonably practicable to set out the consultation start and end dates.

To maintain a record of the Council’s plan-making progress, a schedule of amendments will be published on our website from when the first update occurs.

The Local Plan Timetable replaces the previous requirement to adopt a Local Development Scheme.

The table below outlines the Local Plan Timetable for the preparation of the Nuneaton and Bedworth Borough Local Plan which will cover the administrative area of Nuneaton and Bedworth Borough Council (ONS code E07000219).

This timetable takes effect from 29 June 2026.
