To approve and proceed for Officers to seek advice when absolutely necessary from Counsel for the Examination and adoption phase of the proposed Borough Plan.

REASON FOR THE DECISION

To ensure that any information provided by the Council during the Examination process is legally sound.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED IN MAKING THE DECISION

The Council could choose that no Counsel advice is sought for the Borough Plan Examination process. If this option was chosen, the Examination could fail, and considered unsound by the Planning Inspectorate – Secretary of State and to which end the Council would not be able to adopt the new Borough Plan. As the Plan would then be more than five years old, it could be considered out of date and open the Council up to speculative planning applications.
