<p>The Issue</p> <p>Following a request from Cllr. Michael Green on behalf of Father Simon Hall, the Council wishes name a currently unnamed section of road within the Borough Angels Way. Cabinet on 6th March 2024 gave the Assistant Director for Governance & Democracy delegated authority to implement the process for the change of name.</p> <p>Notice of the proposed change was published in the press and the Magistrates Court has confirmed that no appeal against the proposed name has been received.
