NOTICE TO PERSONS UNKNOWN

On the 17th December 2024, the Honourable Mr Justice Cotter granted a 12 month injunction order against the 54th Defendant (Persons Unknown forming unauthorised encampments within the Borough of Nuneaton and Bedworth) (the '**Injunction Order**'). The Injunction Order was amended under the slip rule CPR 40.12 and re-sealed on 28 January 2025. A copy of the Injunction Order can be found at www.nuneatonandbedworth.gov.uk/injunction.

Pursuant to paragraph 7 of the Injunction Order, the Claimants now apply for the renewal of the Injunction Order for a further 12 months (the '**Renewal Application**').
