We will accept one grave owner only. The new grave owner will have the right to be buried in the grave (if space is available) and give permission for any future burials or interments of cremated remains (if space is available). They will also have the right to place a memorial stone or update an existing memorial stone, provided the memorial meets the cemetery regulations.
