## 1.0 INTRODUCTION

- 1.0 This document is the 'Consultation Statement' for the Gypsy and Traveller Site Allocations Development Plan Document (DPD). This statement sets out how the public and other stakeholders were consulted on the DPD, the issues that were raised by stakeholders in relation to the DPD, and the Council's responses to those issues.
- 1.1 The Issues and Options version of the Gypsy and Traveller Site Allocations DPD was approved for public consultation by the Council's Cabinet on 26<sup>th</sup> May 2021. A public consultation was held from 11<sup>th</sup> June 2021 to 6<sup>th</sup> August 2021. Consultees on the Council's consultation database were notified of the consultation including statutory consultees and adjoining local authorities.
- 1.2 Hard copies of the DPD were made available at Nuneaton Town Hall. A press release was issued, the consultation was posted on the Council's Facebook and Twitter accounts, and all information was held on the Council's dedicated consultation webpage. Comments could be emailed to planning.policy@nuneatonandbedworth.gov.uk or posted to Planning Policy, Nuneaton and Bedworth Borough Council, Town Hall, Coton Road, Nuneaton, CV11 5AA. A telephone number was also provided for those who wanted to ask questions or seek further information. The response form for the consultation that was held is contained within Appendix 1 of this document.
- 1.3 Comments received during the public consultation along with the Council's response to those comments are set out in Table 1 below.

This is a concern for Public Health as there is a need to improve access to healthcare services, particularly among Gypsies and Travellers, as this can be seen as a barrier to good health and wellbeing. Accessing healthcare services are important because studies have consistently shown that members of this community experience inequalities in health and poorer health outcomes when measured against the general population. There is a need to ensure that sites are located within a reasonable distance to GP practices to promote active travel / healthcare services to improve health and wellbeing outcomes and reduce inequalities in health.  Furthermore, Gypsies and Travellers are less likely to receive effective, continuous healthcare including access to primary care and community care services, maternal and childcare, screening and immunisation, and end-of-life and palliative care. Barriers to health care include racism and discrimination, cultural beliefs, illiteracy, negative experiences, traditional role of the family, inadequate health service provision, and no fixed abode. Having access to services at a distance which allows for active travel could help improve health and wellbeing outcomes and reduce health inequalities across the Borough.
