Executive Summary

The Gypsy and Traveller Site Allocations Development Plan Document (DPD) is a planning document that sets out how and where the Council will provide for new traveller pitches in the borough. The DPD has to be subject to a statutory consultation during which everyone is permitted to make comment. It is anticipated that the DPD will have a positive impact on groups with protected characteristics.

1.2) What is the aim/purpose of the Function?

The Gypsy and Traveller Site Allocations Development Plan Document (DPD) is a planning document that sets out how and where the Council will provide for new traveller pitches in the borough. Policies DS4 – Overall development needs and H3 – Gypsies and Travellers of the adopted Borough Plan set

out the need for new pitches for travellers by 2031 to be 39 residential and 5 transit pitches. This has been updated by a newer assessment of accommodation needs which sets out a different need. However, the DPD will (subject to availability and acceptability) provide an appropriate number of pitches to meet the identified need.

1.3) What impact will this Function have on a particular group or the Borough as a whole?

The DPD will not have any direct or specific impact on any particular group or the Borough as a whole.

1.4) Is it anticipated that any group benefit from this Function?

It is anticipated that the DPD will benefit the travelling community through the provision of new sites to facilitate their way of life.

1.5) Is it anticipated that any group will be disadvantaged from this Function?

It is not anticipated that any group will be disadvantaged by the DPD.

The accommodation assessments and the Borough Plan set out the numerical requirements for new traveller pitches and the Borough Plan sets out broad criteria for the assessment of new traveller sites. It has been decided to use the newer data for need. Legislation sets out the duties the Borough Council has to meet in providing traveller pitches.
